Comm. Duderstadt informed him that the Board is waiting to hear from AC Finnigan on the test that they were doing on removing one of the patches. If the glue comes off then they want keep one off but if it doesn't they want to replace it with a flag patch.

3. Local 2393 was invited to the Kingston parade. Wanted to know if there was going to be a problem because of the patch issue. Wants clarification so we don't have the same problems as last year.

Comm. Muckenhaupt stated that the Board had given unrestricted permission to Local 2393 to march in Kingston's parade.

- B. Mechanic Joe Tarquinio
  - 1. We need to replace 3261. Need to buy a new squad and the old squad would be the new 3261. On State bid for \$37K, tops \$40K. A chassis alone would cost \$43K, if we went local.

DC Pells suggested the Board approve a permissive referendum because that will help the process, as this takes 30 days. Will get Attorney Olson write the resolution and attach it.

A motion was made by Comm. Bollmann and seconded by Comm. Muckenhaupt to approve the purchase of a new utility truck in the amount not to exceed \$45K to come out of the Capital Equipment Reserve Fund, subject to permissive referendum.

Resolution as written by Attorney Olson sent to the Secretary via e-mail on February 12<sup>th</sup>:

BE IT RESOLVED, by the BOARD OF FIRE COMMISSIONERS of said Fire District as follows:

FIRST: That the District, due to its size and increasing need, must add/replace equipment in the form of a Utility Truck.

SECOND: The Board has determined that the purchase of said equipment is economically feasible and can meet the requirements and the needs of the District in the future and that the District has the available station space to house the new apparatus.

THIRD: The Board, therefore, by the adoption of the above resolution authorizes the purchase by bid of a sum not to exceed \$45,000.00 to purchase a new Utility Truck. Said funds to be expended from Capital Equipment Reserve Fund subject to applicable law with reference to Capital Reserve Fund transfers.

FOURTH: This resolution is adopted subject to a permissive referendum as provided by law.

FIFTH: This resolution shall take effect immediately. The question of the adoption of the foregoing resolution was duly put to a vote on roll call, which resulted as follows:
