 - 2. Information received from PenFlex regarding Service Awards, was sent to Gerry Comatos, in response received Resolution as follows:

WHEREAS; under the current provisions of the Service Award Program, active volunteer firefighters of the Arlington Fire District who are eligible to participate in the Program can earn credit under the Point System for a maximum of 40 years or up to the time the firefighter attains the Entitlement Age (whichever comes first); and

WHEREAS; the Board of Fire Commissioners believes Service Award Program service credit should be awarded to all active volunteer firefighters who earn such credit under the Point System, regardless of age; and

WHEREAS; a proposal has been made up to amend the Service Award Program for active volunteer firefighters of the Arlington Fire District; NOW, THEREFORE

BE IT RESOLVED, that:

The Board of Fire Commissioners of the Arlington Fire District, as authorized by Article 11-A of the New York State General Municipal Law, directs that there shall be a referendum of eligible voters of the Arlington Fire District to determine whether the Service Award Program shall be amended effective January 1, 1999.

For each year of service credit earned, a participant shall be paid a \$20 monthly Service Award in the form of a ten year continuous and certain life annuity.

Should the eligible voters of the Arlington Fire District approve this amendment, persons who continue to be active volunteer firefighters of the Arlington Fire District after attaining the Entitlement Age and after beginning to receive payment of his or her Accrued Service Award, shall continue to have the opportunity to earn service credit under the Point System (up to a maximum of 40 years) and thereby increase their monthly payment Service Award. The additional monthly Service Award payments earned during a calendar year by a participant after attainment of the Entitlement Age shall commence to be paid as of the January 1 in the next succeeding calendar year.

All other provisions of the Arlington Fire District Service Award Program which require voter approval shall not change and the Program shall continue to be administered by the Arlington Fire District Board of Fire Commissioners in accordance with Article 11-A of the New York State General Municipal Law, as such law is amended from time to time.

Such public referendum of the Arlington Fire District shall take place on April 13, 1999 between the hours of 6:00 p.m. and 9:00 p.m. Eastern Standard Time at Fire District Headquarters, 11 Burnett Boulevard, Poughkeepsie, New York.

A motion was made by Comm. Chiumento and seconded by Comm. Richardson to approve the aforementioned Resolution.
