- A. Chief Bill Phillips
  - 1. One Item for Executive Session.
  - 2. Silent Running Policy will be tabled until Workshop meeting, due to lack of Commissioners to discuss.
  - 3. Wanted to know if a plaque was done for John Hellmann.
    - DC Pells stated that it was already taken care of.
- B. Deputy Chief Pells
  - 1. One (1) Personnel Item for Executive Session
  - 2. Wanted clarification on requirements for Chief officers and Company officers.
    - A. Are the Commissioners going to be looking at making recommendations or requirements for company officers? (Presently is states recommendations)
    - B. Comm. Chiumento stated that each company has their own bylaws, which has requirements. The company has the right to waive certain requirements. If the Board adopted them, then they don't have the right. They would have to come to the Board for each exception they would want. The Board has the right to require, but not a nomination on a company level.
    - C. Comm. Chiumento suggested that DC Pells email each Commissioner for their opinion, then get a consensus.
  - 3. Plymo-vent Specs.
    - A. DC Pells stated that it would take care of the vehicles here now, and also take care of the Grievance.

Has an expiration of December 31, 2000, or sooner, but no later than. Understanding of a two week written notice when we are going to stop it.

  - 5. Rules and Regulations Leave of absence
    - A. "Active member requirements" and "Active member current members requirements" having to do with leave of absence. Need a schedule on members who takes a leave of absence from the fire district or outside the district. Specifically someone who has gone and has had no touch with the district. Read amendment. ### A. EMS Director John Kloepfer

- 2. Lyme Disease Vaccinations discussion from last meeting.
  - A. In pamphlet, it states that public employers are required, but not required for fire departments. Assistant EMS Director Violante contacted Kevin Cox, who stated its mainly for employees who work as forest rangers, surveyors, etc., not for firefighters. Carol Butte was also contacted, she said the same thing, unless your in a high risk area. Dutchess County is one of the highest risk areas.
  - B. DC Pells suggested to have the District cover co-payments for those who submit the shot to insurance and cover the whole cost for those who do not have insurance.

A motion was made by Comm. Chiumento and seconded by Comm. Philipp to adopt a Lyme Disease education, via pamphlets mailed with an accompanying letter offering to pick up the co-pay or whatever the insurance doesn't cover for the cost of the shots, if they desire to get the shots and to investigate getting a video.
