RESOLUTION AUTHORIZING EXECUTION OF CLOSING DOCUMENTS TO ACQUIRE ROCHDALE FIRE COMPANY PREMISES

WHEREAS, on April 3, 2023, the Board of Fire Commissioners of the Arlington Fire District ("Board") authorized entering into a contract of sale with Rochdale Fire Company No. 1, Inc. ("Rochdale Fire Company") to acquire the parcel of real property and all improvements erected thereon located at 1075 Dutchess Turnpike, Poughkeepsie, New York, Grid No. 14-6262-02-969592 ("Rochdale Firehouse Premises"), for the sum of \$300,000 ("Contract of Sale"); and

WHEREAS, on or about June 26, 2023, the Contract of Sale between the Board and Rochdale Fire Company to acquire the Rochdale Firehouse Premises was duly executed; and

WHEREAS, Rochdale Fire Company has obtained final approval from the New York State Attorney General to convey the Rochdale Firehouse Premises to the Arlington Fire District for the sum of \$300,000;

NOW THEREFORE, **BE IT RESOLVED**, that the Board of Fire Commissioners of the Arlington Fire District hereby authorizes the Chairman and/or his designee to execute all closing documents necessary to acquire title to the Rochdale Firehouse Premises.

As a result of Executive Session, Comm. Jackson made a motion that the Arlington Fire District purchase from the Village of Wappingers, 2011 Seagrave F-550 Light Duty Utility Vehicle which has been surplused by the Village of Wappingers subject to final approval by the Village Board in the amount of \$68,000. Seconded by Comm. Chiumento.

As a result of Executive Session, Comm. Chiumento read the following Resolution:

RESOLUTION

WHEREAS, on January 24, 2022, at a regular meeting of the Arlington Fire District ("Fire District") Board of Fire Commissioners ("Board"), Dutchess County, New York, , the Board duly adopted a Resolution, an abstract of which is as follows: the Fire District Board of Fire Commissioners, does hereby authorize the purchase of two fire apparatus – (1) Seagrave TB50CT Marauder pumper with 14" extended compartments and high-rise tray ("Pumper"); and (2) Seagrave model TB50CT Marauder rescue pumper with 28" extended compartments and hydraulic ladder rack ("Rescue Pumper") – for the total amount not to exceed \$1,800,000 which purchase shall be funded from the District's Capital Equipment Reserve Equipment Fund, subject to a permissive referendum; and

WHEREAS, the Board entered into a Contract with Seagrave Fire Apparatus, LLC ("Seagrave"), dated as of January 25, 2022, to purchase the Pumper and Rescue Pumper for the total agreed upon price of \$1,664,337.00; and

WHEREAS, after a site visit in October 2022, change orders for the Pumper and Rescue Pumper were agreed to in the total amount of \$13,086.00, raising the total cost of the Pumper and Rescue Pumper to \$1,677,423.00; and

WHEREAS, Seagrave has informed the Board that, as a result of supply chain disruptions and material cost increases, the manufacture and delivery of said fire apparatus at the amended total agreed upon price of \$1,677,423.00 has become commercially impracticable; and

WHEREAS, after a series of negotiations, Seagrave and the Board have reached an agreement to increase the total price of the Pumper and Rescue Pumper in the sum of \$180,000 to be divided equally between the Pumper and Rescue Pumper;

BE IT HEREBY FURTHER RESOLVED, that the Board of Fire Commissioners approve an Amendment to the Contract with Seagrave in the form attached hereto; and further authorizes the Chairman or Fire Chief to sign said Amendment to the Contract.

AMENDMENT TO ORDER TERMS

THIS AMENDMENT TO ORDER TERMS (this "Amendment"), dated as of 2024, is made by and between Seagrave Fire Apparatus, LLC, 105 East 12th Street, Clintonville, WI 54929-1518 ("Seller") and Arlington Fire District, 11 Burnett Boulevard, Poughkeepsie, NY 12603, by its authorized representatives ("Purchaser" and, together with Seller, the "Parties").

BACKGROUND

This Amendment applies to each order, contract, agreement, instrument, term or undertaking ("collectively, the "Order Terms") relating to two (2) Seagrave custom fire apparatus, model TB50CT Seagrave Custom Marauder Pumper and numbered SO #78M33 and model TB50CT Seagrave Custom Marauder Rescue Pumper and numbered SO #78M34 (the "Apparatus"), including, without limitation, the Contract between Seagrave Fire Apparatus, LLC, and the Arlington Fire District, Poughkeepsie, NY, dated January 25, 2022. The manufacture and delivery of the Apparatus under the Order Terms as in effect prior to this Amendment (the "Original Order Terms") has become commercially impracticable. The Parties desire to enter into this Amendment to provide for an equitable modification of the Original Order Terms.

NOW, THEREFORE, for and in consideration of the premises, the covenants contained in this Amendment and the Order Terms, and other good and valuable consideration, the receipt, sufficiency and adequacy of which are acknowledged by the Parties, the Parties hereby agree as follows:

- 1. <u>Material Price Increase</u>. The Original Order Terms are hereby amended to add a material price increase in the amount of One Hundred Eighty Thousand Dollars (\$180,000) (the "<u>Material Price Increase</u>"), to be divided equally between the Apparatus, and shall be payable by Purchaser to Seagrave upon delivery and acceptance of the Apparatus and prior to the Apparatus being placed into fire service. The Material Price Increase shall be payable in addition to the amounts otherwise payable under the Original Order Terms. This is a one-time Material Price Increase, and no additional Material Price Increases will be added to the Original Order Terms.
- 2. <u>Delivery of Apparatus</u>. The Original Order Terms are hereby amended to provide for shipment of the Apparatus to Purchaser no later than April 30, 2025. In the event a change order will delay this delivery date, a revised date will be specified in the change order. Delays due to strikes or other force majeure events beyond Seagrave's control will be just cause for delay in delivery.
- 3. <u>Effect of Amendment</u>. This Amendment shall constitute an amendment to the Original Order Terms. To the extent of any conflict between the terms of this Amendment and the original Order Terms, the terms of this Amendment shall control. Except as provided in this Amendment, the Original Order Terms shall remain in full force and effect.

4. <u>Multiple Counterparts</u>. This Amendment may be executed in multiple counterparts, each of which shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement.
