1. Follow up on 32-15; lengthy discussion held on the estimates received from Frank & Sons and Brega Commercial Collision Corporation.

<u>Brega Commercial Collision Corporation</u>: no experience with painting fire trucks, two estimates received; one to do painting of the roof and the other the cab, warranty is covered for time we have vehicle - for work and labor. \$99 per hour body work labor. Anticipates having 32-15 for 6+ weeks. Was told 3 hours work equals one business day.

<u>Frank & Sons</u>: past history of work done by them, (32-11 & 32-52), one estimate received, they will touch up roof, warranty is covered for time we have vehicle - for work and labor. \$85 per hour body labor work. Anticipates having 32-15 for $2 - 2\frac{1}{2}$ weeks.

A motion was made by Comm. Seco that this vehicle be repaired by Brega Commercial Collision Corporation, repairing 32-15 as per estimate, not to exceed the \$13K. Any additional work found will have to be approved. Seconded by Comm. Armstrong.
