It is hereby agreed by and between the Arlington Fire District (hereinafter referred to as "DISTRICT' and the Arlington Professional Firefighter's Association, IAFF Local 2393 (hereinafter referred to as "ASSOCIATION") as follows:

- 1) Both parties agree that it benefits both the DISTRICT and the ASSOCIATION to ensure that recruit firefighter training academies are staffed with appropriately trained and motivated firefighters and officers.
- 2) To facilitate this the DISTRICT and ASSOCIATION agree to allow members of the ASSOCIATION to be voluntarily and temporarily reassigned to work these programs for the hours listed under "Firefighters on Days" in accordance with Article XII.
- 3) When reassigned to these temporary appointments members shall:
 - a. Be compensated at Step 3 rate in accordance with Article XXXIV.
 - b. Be provided with appropriate transportation and/or lodging.

Comm. Van Itallie made a motion to approve that agreement. Seconded by Comm. Jackson.

With no further business to conduct, Comm. Van Itallie made a motion to adjourn the meeting. Seconded by Comm. Chiumento.
