X. DISTRICT STAFF ITEMS

 - 1. Requesting authorization to renew the Statement of Work for the Volunteer Recruitment Coordinator which expires December 31, 2019; budgeted \$1,000 for 2020; no change in hourly rate; requesting submission of monthly vouchers to quarterly.

 - 2. Raymond Avenue School Development– presented a Power Point presentation to the Town of Poughkeepsie Town Board regarding AFD's position on the project and ongoing opposition to the PILOT. Would be a \$2.1 million loss in fire tax revenues over 25 years, which forces the community to subsidize that project financially until year 2039. Developer is anxious to appear before the BOFC due to a deadline to close on the property, Chief suggested the second meeting in January, however not ready to meet, we only have proposed numbers; Chief met with IDA; Executive at IDA feels the Fire District has the right to be heard regarding PILOT's. As per the IDA, the developer must submit a

business plan to the Town, the IDA and Fire District for a PILOT. Chief FOIL'd for those documents which do not exist.

The Board thanked Chief Steenbergh for his continued work on this project.

- 3. Congratulated Comm. Jose Seco on the completion of his term and wished him a well deserved retirement from the Board of Fire Commissioners.

XIV. **OPEN ITEMS**

As a result of Executive Session, a motion was made by Comm. Seco to allocate funds from the 2019 excess funds from the budget 2018 which we have already allocated the \$337K for the Employee Accrual Benefit and that left us with \$669K. We would like to allocate the additional \$600K to the Employee Benefit Accrual Fund and \$69K to be left or carried over to 2020. Seconded by Comm. Longi.

Comm. Seco stated he left out "Commissioners Items". Thanked everyone for the opportunity given to serve on the Board and for the District. Wished the best of luck to the elected Commissioners and congratulated them. One issue that keeps coming up in terms of Commissioner items. Stated that Commissioners come on Board in this District without tools to perform their jobs. Only issued two ID cards. Everyone else in the District has laptop, phone, etc., ID as they arrive at the scene.

Comm. Seco stated that any Commissioner which has been on the Board for more than two years, starting with current Board, have issued two ID cards, be issued a jacket, be issued a baseball cap and a protective vest to be used as a summer jacket than in the winter and a \$20 monthly compensation for reimbursement or not (up to the individual Commissioner) for use of cell phones, tablets, PC's, etc. for reimbursement of expense. It's an expense, not a gift. Commissioners are using, printing, monitoring and be expected to keep up with emails which no reimbursement for such expense takes place.

A motion was made by Comm. Seco for the current Board going forward as such. Seconded by Comm. Valdez.

- Motion Carried, 3 – 1 (Comm. Adams opposed)

Comm. Seco said he has donated three sets of full turnout gear at a value of \$21K - \$27K which offsets this cost for now and the future.

With no further business to conduct, a motion was made by Comm. Seco to adjourn the meeting. Seconded by Comm. Valdez.
